TAKO HUNT:

The Tako hunt, cancelled in January, has been rescheduled for *April 7*, *2013*. Dive where ever you want and weigh in at Frank's house by 2:00 PM or DQ'd. This is a swim out 3 prong event to aid in re-energizing your physical condition and activate your skills and reaction to "moving" targets after your holiday celebrations (those who didn't dive the 3 prong meet). *This meet is open to all interested persons – AHK and non-members may join in!!* The minimum eligible tako weight is 2 pounds, no scooping in the tako categories. Awards are total weight: 1st, 2nd, 3rd; heaviest (single tako) 1st, 2nd, 3rd. A special award Will be given for the heaviest mystery fish caught with 3 prong and must be one of the Following: 12 inch minimum; all goats, aawa, awaawa, mu, enenui, uhu; 16 inch minimum; opelu kala, horn kala; 18 inch minimum; all blue water fish, awa, uku, jacks. No minimum; roi, toau, taape. Study the list carefully as this is a fun meet you can only have 1 of each of the above except for roi, toau, taape. The last 3, if drawn, will be total weight. Entry fee is \$20. Mail monies and form to Terrence by April 1st, otherwise entry fee is \$25. Club will Provide lunch, **bring your own drinks**.

DIVING WITH DAD:

It is with great sadness that we inform you that Alii Holo Kai will no longer be hosting our annual DWD tournament. Without getting into detail, there are problems with securing a park use permit from the city.
