FUND\$ DIVE RESULTS

Mahalo to all the divers who participated in the AHK Fund\$ Dive on September 28th! The objective of this dive was to shoot fish and fundraise for the Annual AHK Christmas Party in October! Poor weather conditions made it challenging (the report from all the divers was murky water everywhere!), but divers still came in with fish. Divers were allowed to use boats, kayaks, or swim from shore, and had to be at Frank's house for the weigh-in by 1:30 p.m. Most divers elected to swim from shore, but a few kayaked. Scoring was based on points, and

certain fish were worth more points per pound. The desired "food" fish (uhu, kumu, and pelagics) were valued at 10 points per pound. "Rubbish fish" were only ½ point per pound. Prizes were awarded to the top 3 veteran "uku" divers and the top 5 less experienced "uhu" divers. Congrats to the winners!

NEXT EVENT: KUMU HUNT!! (November 9, 2014)

The Kumu Hunt is the last AHK meet of the year, and it is one of our most popular events. *Open to Ali'i Holo Kai members only!* Space is limited to the first 30 divers, so turn in your applications early! In this meet, divers target the highly prized Kumu and other food fish, which will be enjoyed by the divers, family, and friends at the Awards Banquet that evening. All fish must be donated. Winners traditionally have the privilege of cleaning fish and scrubbing down the driveway afterwards! This year, the Awards banquet will be held at Happy Days restaurant (3553 Waialae Ave., Kaimuki) with a multicourse Chinese dinner, including fresh-caught fish, awards, and door prizes.



KUMU HUNT INFORMATION AND RULES:

When: Sunday, November 9, 2014

Location: dive anywhere on Oahu, swim out only (no kayaks)

Weigh-in: 1:00 p.m. at Frank's house (3446 Pakui St., Palolo)

Entry fee: \$35 per diver to cover awards, pupus, and banquet.

Deadline: Mail your application and entry fee to Jason Hijirida; must be postmarked by November 3rd.

Time: Divers may begin diving at sunrise, and must be at Frank's house for the weigh-in by 1:00 p.m. at the latest.

Scoring: Scoring will be by total weight (no points per fish). Only 3 largest goatfish will score. Tie decided by total length.

Size limits:

Goatfish (all species): 11" minimum Pananu (Star-eye parrotfish): 12" min.

Papio (all species): 12" min.

Toau: 8" min.

Roi: no minimum size

AWARDS:

1st, 2nd, 3rd largest goatfish 1st, 2nd, 3rd total weight

1st largest pananu

1st largest papio (under 10 lbs)

1st largest toau

1st most roi (by total weight) No scooping of more than 2 awards per diver (one for goatfish, one for special category)

DIVE RULES:

- 1. No boats, kayaks, motorized propulsion, or scuba
- 2. Divers must enter the water from the shoreline of Oahu
- 3. Fish lost due to bad shot is fair game to all other divers.
- 4. No mutilated fish will be scored
- 5. All divers must weigh their fish
- 6. Weighing in undersized fish (by state law) will result in DQ
- 7. Weigh-master's decision is final

Dive safety: dive with a buddy... for his safety and yours! All divers are required to use a dive flag. Dive knife is highly recommended. Each diver is responsible for his or her own safety. Don't dive somewhere you can't handle; know your limits. Weigh-in will not begin until all divers are accounted for. If you are unable to be back in time, please call Jason at (808) 386-3483.
